Town Ordinance
2014-01

Article I

Conduct on Beaches and Parks –
281-6. Animals

Amendment to: Items A & B

New language is as follows -

- A. No Dogs shall be allowed on any Town Beaches. Dogs shall be permitted above the swimming and beach areas as long as they're on a leash and under the control of its owner or some other person at all times. The effected Beaches are: School House Beach, Gislason Beach and Sand Dunes Beach
- B. Dogs shall be allowed in other Town parks and properties as long as their on a leash at all times and under the control if their owner or some other person.


