
1. Conduct Airport Master Plan and Airport Layout Plan update
2. Demolition/Removal of Hanger #1 and pit toilet building
3. Construct addition to present vehicle storage building to accommodate Pilot Welcome Center to include flight planning room, meeting room and restrooms with new septic system
4. Replace one turf runway with paved surface runway
5. Construct taxiway to runway(s)
6. Acquire land in runway approaches for airport development
7. Purchase mowing/clearing equipment
8. Conduct wildlife site visit and assessment
9. Replace airport lighting and NAVAID
10. Clear and maintain runway approaches as stated in Wis. Administrative Code Trans 55 and any related and necessary work
